ORDER

- 1.The Chairman and Managing Trustee of Nehru College of Educational and Charitable Trust, Palakkad Main Road, Kuniyamuthur, Coimbatore (Kerala Campus Office: Nila Gardens, Pampady, Thiruvilwamala, Thrissur) had submitted application for starting a new Un-Aided Arts and Science College for the academic years 2022-23 & 2023-24 by name Nehru College of Arts and Science, Lakkidi, Mangalam (P.O.), Palakkad vide reference cited first.
- 2. After completing all the statutory procedures, including inspection by District Level Inspection Commission, Palakkad, and after consideration by the Syndicate, recommendation of the University for starting a new Un-aided Arts and Science College by name, 'Nehru College of Arts and Science, Lakkidi, Mangalam (P.O.), Palakkad under the management of Nehru College of Educational and Charitable Trust, Palakkad Main Road, Kuniyamuthur, Coimbatore. Kerala Campus Office: Nila Gardens, Pampady, Thiruvilwamala, Thrissur with programmes, viz., (i) B.A. English Language & Literature (ii) B.A. Journalism and Mass Communication and (iii) B.Sc. Computer Science for academic year 2023-24 was forwarded to Government vide letter cited second, for obtaining views of the Government as stipulated in Calicut University First Statutes, 1977.
- 3. Based on the recommendation of University, Govt. of Kerala had accorded Administrative Sanction vide G.O. cited third, and issued No Objection Certificate (NOC) vide G.O. cited fourth, for commencement of new Un-Aided Arts & Science College during academic years 2022-23 & 2023-24.
- 4. Thereupon the Chairman/ Managing Trustee of the proposed College has requested to grant affiliation for the new Un-Aided Arts & Science College for academic year 2023-24, along with

notarised affidavit in prescribed format and required fee.

- 5. The meeting of the Syndicate held on 13.04.2023, considered the matter of granting provisional affiliation to new Un-Aided Arts and Science College by name, Nehru College of Arts and Science, Lakkidi, Mangalam (P.O.), Palakkad for the academic year 2023-24 under the management of Nehru College of Educational and Charitable Trust, Palakkad Main Road, Kuniyamuthur, Coimbatore. Kerala Campus Office: Nila Gardens, Pampady, Thiruvilwamala, Thrissur with programmes, viz., (i) B.A. English Language & Literature (24) (ii) B.A. Journalism and Mass Communication (40) and (iii) B.Sc. Computer Science (24) during the academic year 2023-24 and approved the same vide item No 2023.390*.
- 6. Considering the matter in detail, sanction has been accorded by the Vice Chancellor for implementation of the aforesaid resolution of the Syndicate.
- 7. Orders are, therefore, issued granting provisional affiliation for starting new Un-Aided Arts and Science College for the academic year 2023-24 as shown below.

- 8. Provisional affiliation granted for commencement of new college is subject to the following terms and conditions.
 - i. Affiliation granted is strictly provisional and only for the academic year 2023-24.
 - ii. The college has to apply for continuation of provisional affiliation for the ensuing academic year by remitting fee fixed by the University. Renewal of provisional affiliation in subsequent academic years is subject to submission of renewal of NOC from Government of Kerala for respective academic year.
 - iii. Educational agency/college shall abide by the conditions stipulated in No Objection Certificate issued by Government, vide G.O. cited fourth.
 - iv. Admission to next academic year shall be made only after obtaining prior permission from the University. The management should abide by the provisions of University Act, Statutes and Regulations of the University with regard to admission of students, collection of fee, etc.

- v. Selection and admission shall be made only on the basis of rules and regulations of the University/Government and on the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.
- vi. Conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to University of Calicut.

vii.Principal shall strictly follow the approved syllabi, available on the University website (www.uoc.ac.in) for selecting complementary/common courses.

viii.Principal shall ensure that all details of the College are uploaded and updated in the Centralised College Portal.

- ix. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, Institutions shall take appropriate measures for prevention of ragging in any form.
 - x. Violation of any of the above will leads to the cancellation of affiliation.
- 9. Resolution of the Syndicate held on 13.04.2023 vide Item No.2023.390 is thus implemented.
